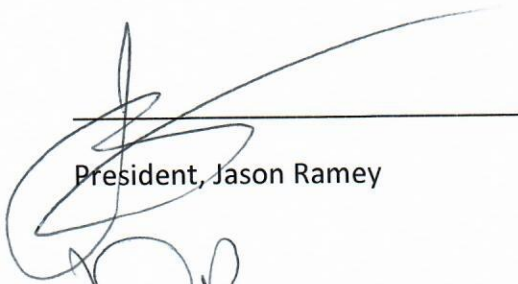
of the Night Vision glasses increased \$270.00; Motion was made to approve the cost of \$2,400.00, All in favor. Motion passed 4-0.

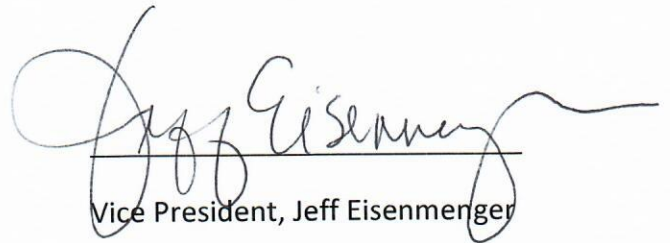

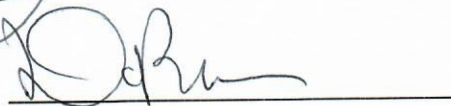

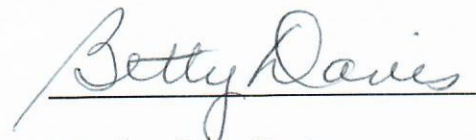
