He has been advised that it needs rezoning because is not legal with the present zoning. He has two options (1) get a variance or (2) request (PUD) Planned Unit Development. The Planning Commission told him to write down all the uses he plans for the elementary and decide which options he wants before anything can be done. If he chooses PUD, the ordinance needs to be written because one does not exist at this time. He was told he has to decide and that the town cannot decide for him. There was a discussion about parking and getting along with his neighbors, so that they are willing to share the parking. Mr. Lochard is planning to work to improve the parking lot and have parking lines, so that people know where to park. The Planning Commission expects to hear from Mr. Lochard at next months' meeting.
