The R3 Zoning was our next discussion. R3 is a mixture of multi-single, multi urban dwellings, with no minimum lot size. R1 and R2 have 60 ft. minimum lot width. It was suggested to change it to 65 feet and that would have to be done with a public hearing next month.

Mark Carpenter made motion to make the changes in the lot width for future developers with a public hearing June 14, 2021, at 6:00 P.M. during our regular meeting night. Steve Scott 2nd the motion. All approved.

Southern Comforts update of the inspection by Tim Guyer was made. Tim there was 3 minor infractions to report. (1) Dryer vents (2) CFI plug-ins (3) Cover Plates. Tim did his inspection on March 29th and will follow up to see if everything was corrected before signing off.

Indian Creek is requesting a Cattle Barn Sign. They were told to get a permit stating size and where it would be located. They said they would put it where ever the town wants it put.
