Jason Ramey motioned to make payment for new dump truck to take \$8500.00 out of machinery and equipment fund and have the remainder split 50/50 between water and wastewater accounts. Princes Lakes would like to re-negotiate the water contract since they have their new water tower at capacity. Princes Lakes can guarantee a higher daily usage and with growth the Council felt this should be re-negotiated. Jessica will work with Prices Lakes and Lee to renegotiate the contract.
