 - a. Lee Rogers Utility / Street Superintendent pages 44-45

Lee Rodgers presented a proposal for the storm water drainage at the park. The proposal is approximately \$25,000. Lee Will send copies of the proposal to the Council.

Lee Rodgers gave quotes on the Spring Lake lift station repair. Jeff Eisenmenger made a motion to allow BBC Pump & Equipment to do repairs with possibly excavation on the Spring Lake Lift Station not to exceed \$29,000. Jerry Rafferty 2nd. Motion passed 5-0. February. Trinity Pension Consultants fees to be paid by the Town and if the law states something different then we will comply by the law. The motion will be made to allow for the contingency stated above to allow fees as the law allows under the plan presented or a different plan and if the law requires fees to be paid different than the Council accepts it being done in accordance with the way the law states it to be done. Complaint 4: Resident Pam Palmer stated there is an extreme amount of erosion in her yard due to an increase of surface and ground water directed into the small stream in front of the yard. The erosion is to the point structural damage is close to the foundation of the house. Pam brought pictures of the erosion to show the Council. Pam stated she had written the Board a couple years ago because of the increase amount of storm water drainage from Lancaster and it was ruining her yard. She did not hear back from anyone. Pam stated this started before any of the construction started on the east side of Lancaster. Lee Rodgers is not sure but thinks the County may have assessed the drainage for Lancaster Subdivision when the plans were submitted. Pam said she has spoken to the County and they referred her to Trafalgar, the County does not take care of anything within the Town limits. Jerry Rafferty stated the ditch with the runoff has always been there even when it was farmland. Jessica Jones will contact the County to see if she can find out more information and follow up with Pam.
