For Year 2022**

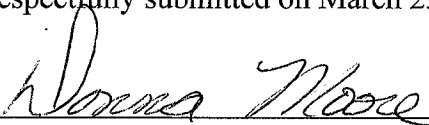
To the Trafalgar Redevelopment Commission (“RDC”):
